1. WELCOME / MEETING PROCEDURES

2. CALL TO ORDER

ETS GSA TAC Chair Sarah Woolf called the meeting to order at 2:01 p.m.

There was not a quorum of the West Turlock Subbasin GSA TAC at the time the East Turlock Subbasin GSA TAC called the meeting to order. Action items (of the WTS GSA TAC) would not be heard until another member agency from the West Turlock GSA TAC joined the meeting.

4. MEETING MINUTES

A. Minutes of the October 10, 2023 Regular Joint Meeting of the West Turlock Subbasin GSA and East Turlock Subbasin GSA Technical Advisory Committees

All voted in favor with none opposed. The Chair declared the motion carried.

5. BUDGET UPDATE

WTS GSA Treasurer Michael Clipper provided an informational update regarding the account balances for the West Turlock Subbasin and Turlock Subbasin (basin-wide) accounts.

ETS GSA TAC Chair Sarah Woolf provided an informational update regarding the account balance for the East Turlock Subbasin.

6. TASK ORDER TO PREPARE THE ANNUAL REPORT

Turlock Subbasin Plan Manager Debbie Montalbano provided information regarding a task order for Todd Groundwater to prepare the Annual Report due April 1, 2024 (covering the previous water year; October 2022–September 2023) for the Turlock Subbasin and to submit the required documentation to the Department of Water Resources on behalf of the GSAs. Ms. Montalbano also noted some minor changes to the scope of work, including contracting/budgeting separately for the water level measurements analysis and that some of the planning meetings have been reduced to help conserve funds.

WTS GSA TAC CHAIR MICHAEL COOKE ANNOUNCED THAT WTS GSA TAC MEMBER CURTIS JORRITMSA, HILMAR COUNTY WATER DISTRICT HAS JOINED THE MEETING VIA REMOTE TELECONFERENCE AND THERE IS NOW A QUORUM OF THE WTS GSA TAC.

WTS GSA TAC Chair Michael Cooke and Ms. Montalbano discussed the cost for this task order, noting the estimate is slightly over what was initially budgeted; however, there are additional funds available within the budget.

There were no public comments.

Action by the West Turlock Subbasin GSA TAC:

Motion by Hilmar County Water District (*Jorritsma*), seconded by Delhi County Water District (*Maldonado*), Authorizing the West Turlock Subbasin GSA TAC Chair to initiate a task order for Todd Groundwater to prepare the Annual Report due April 1, 2024 (covering the previous water year) for the Turlock Subbasin and submit the required documentation to the Department of Water Resources on behalf of the GSAs in the amount of \$135,410. All voted in favor with none opposed. The Chair declared the motion carried.

ETS GSA TAC Chair Sarah Woolf clarified for the record that this expenditure was previously approved by the ETS GSA as part of the budget at the beginning of the year, and that their Board is aware the estimate is coming in a little above and that reserves will likely be used to cover the additional cost.

ITEM 4 CONTINUED -- APPROVAL OF MINUTES BY THE WTS GSA TAC

Action by the West Turlock Subbasin GSA TAC:

All voted in favor with none opposed. The Chair declared the motion carried.

7. TASK ORDER FOR THE REVIEW AND ANALYSIS OF WATER LEVEL MEASUREMENTS

Turlock Subbasin Plan Manager Debbie Montalbano provided information regarding a task order for Todd Groundwater to review and analyze the Fall 2023 water level measurements, noting the data will be incorporated/analyzed as part of the Annual Report.

WTS GSA TAC Chair Michael Cooke spoke regarding the timelines for completing the measurements (first two weeks of November) and noted TID has completed their measurements. ETS GSA Coordinator Mike Tietze noted their measurements are also complete, with the exception of one farm that needs follow-up.

There were no public comments.

Action by the West Turlock Subbasin GSA TAC:

Motion by Hilmar County Water District (*Jorritsma*), seconded by Waterford for Hickman (*Pitcock*), Authorizing the West Turlock Subbasin GSA TAC Chair to initiate a task order for Todd Groundwater to review and analyze the Fall 2023 water level measurements on behalf of the GSAs in the estimated amount of \$17,500. All voted in favor with none opposed. The Chair declared the motion carried.

ETS GSA TAC Chair Sarah Woolf clarified for the record that this expenditure was previously approved by the ETS GSA as part of the budget at the beginning of the year.

8. SGMA RELATED UPDATES

• GSP Implementation

Turlock Subbasin Plan Manager Debbie Montalbano informed TAC members that we are still awaiting GSP review and that we will likely hear from DWR in January 2024.

Ms. Montalbano also noted that data requests will be circulated for the Annual Report.

• Grants

ETS GSA Coordinator Mike Tietze noted we are awaiting review of the joint (ETS & WTS GSAs) grant application for the Domestic Well Mitigation Plan, and also spoke about the ETS GSA having submitted letters of support to UC Davis and the ILRP Coalitions related to an on-farm conservation and innovation grant.

ETS GSA Coordinator Mike Tietze and WTS/ETS GSA TAC Member Lacey McBride provided information regarding a legislative tour related to the MLRP grant, to provide examples of projects/activities that could be supported/funded by this program.

ETS GSA Coordinator Mike Tietze also spoke about a forthcoming field trip to Carpinteria Creek to look at an example site and provided information regarding an RFP to retain a consultant to manage the planned development.

WTS GSA TAC Chair Michael Cooke provided an update regarding the next set of dedicated monitoring wells to be installed, which will likely be put out to bid in the new year, and also noted that some assistance will be needed from the cities and counties for access agreements, etc. TAC members discussed the types of monitoring wells to be installed.

WTS GSA TAC Secretary Jennifer Land spoke about teleconference procedures related to WTS GSA TAC Member Jorritsma's remote participation, clarifying that since we did not notice (agendize) his remote participation/location, there are emergency or just-cause reasons that provide the ability for remote participation. TAC Member Jorritsma announced that he will provide email justification for his remote participation to Secretary Land later today.
