- 1) **WELCOME / MEETING PROCEDURES** Herb Smart (Turlock Irrigation District) provided a brief presentation and explanation regarding conference call procedures.
- **2) IDENTIFICATION OF PARTICIPANTS** Michael Cooke, WTS GSA TAC Chair, took a roll call of meeting participants to include members and the public.
- 3) CALL TO ORDER The meeting was called to order at 2:05 p.m. by Michael Cooke, WTS GSA TAC Chair. The ETS GSA TAC did not have a quorum present.

4) APPROVAL OF MINUTES

- WTS GSA TAC MOTION: City of Turlock (A. Martin) moved, Delhi County Water District (L. Maldonaldo) seconded, that the minutes from the October 22nd regular meeting be approved. All voted in favor with none opposed. The Chair declared the motion carried.
- WTS GSA TAC MOTION: City of Turlock (A. Martin) moved, Delhi County Water District (L. Maldonaldo) seconded, that the minutes from the November 5th special meeting be approved. All voted in favor with none opposed. The Chair declared the motion carried.
- **ETS GSA TAC MOTION:** There was no quorum present for the ETS GSA TAC. Minute approval will be tabled until the December 3, 2020 special meeting.

Michael Clipper, WTS GSA Treasurer, provided a brief report on the current bank account balance and pending invoices. No action was taken.

7) BASELINE FOR FUTURE PROJECTED WATER BUDGET

Dominick Amador (Woodard & Curran) presented the Technical Advisory Committees with the Projected Conditions Baseline. The Groundwater Model is used to simulate the Projected Conditions Baseline, which is the tool used to make planning decisions in regards to the Groundwater Sustainability Plan. The Baseline is a modeled 50 year projection of the conditions in the Subbasin without potential future

projects designed to comply with SGMA groundwater sustainability requirements. There will be a future Project Scenario that evaluates the impacts of potential management actions and projects and their effectiveness in assisting the Subbasin in achieving sustainability.

The presentation included the Baseline modeling approach and assumptions, including the simulation period, hydrology, water demand for both agricultural and urban water use, and water supply for both surface water and groundwater.

The C2VSimTM Baseline development process included the input of precipitation, land use, and urban demand data and surface water supplies to simulate the total water supply and demand and impacts to the groundwater and surface water systems in the Subbasin over the 50-year period.

The Hydrologic Period utilized to produce the baseline simulation included weather and hydrology from the time period 1969-2018, to evaluate a planning period of 50 years. Current conditions of land use and water management and projected increases in urban demand were incorporated into the baseline. Baseline results were presented along with the model results from the historical Study Period 1991-2015 for comparison.

Next Steps for the TACs include:

- Continued Analysis of the Projected Conditions Baseline
 - o Conduct additional QA/QC of the baseline results
 - o Develop details of river seepage and subsurface flows
 - o Evaluate groundwater level hydrographs and contour maps
 - o Develop GSA-level water budgets
- Upcoming Modeling Scenarios
 - Sustainable Yield
 - Climate Change
